### Remuneration:

Freshfields Insurance Brokers (Pty) Ltd receives commission, when the policy is accepted and the premium paid. The level of these commissions vary depending upon product type, with a maximum of 20% of the premium for non-motor business and 12.5% of the premium for motor business, as defined in the Short-Term Insurance Act [No 53 of 1998].

We make every effort to ensure that at all times, we act in your best interests and in no way allow our own interests, potential or actual, to influence our objective performance and the delivery of unbiased and fair financial service to you.

From time to time FIB may receive some form of indirect consideration from a product provider, Insurer or the like. A Gift Register is available for inspection upon request.

For our service, in terms of section 8.5 of the Short Term Insurance Act, we charge a broker fee. The Insurer collects the broker fee on our behalf. This fee is substance for the following services which we provide:

	visit you at your risk address to assist with Risk Assessment, should you request this service
	assist with policy underwriting;
	issue you with a monthly brokerage newsletter regarding an important subject matter;
	assist you in negotiating with the Insurer in the event of a claim.

Any fees due by you to us will be pointed out to you when we provide you with a quote or renewal terms and will also be shown on your schedule.

# What else should you know?

We are an FSP and act as your broker/intermediary. We currently receive more than 30% of our total remuneration from Constantia Insurance Company Ltd (CICL).

# Your insurer:

- must be the one who provides the reason for any claim that is repudiated.
- ☐ must ensure that it writes to you should it wish to cancel your policy and to give you at least 30 days' notice of its intention to do so.

# We undertake:

- ☐ to keep all information you tell us about yourself confidential.
- not to alter any documents you provide us with when submitting them to any Insurer. Where we feel an error has been made we shall advise you prior to submission.
- to never ask you to sign blank documents. All documents, be they proposals or claim forms, should be completed by you to ensure full and correct details.
- to supply you with a copy of any documents used in the preparation of your insurances, when required, free of charge.

#### If you are paying your premiums by debit order:

- your Insurer must provide you with 30 days' notice of cancellation.
   of the debit order.
- ☐ if you are paying for personal insurances you are entitled to a period of 15 days grace in which to pay the premium (other than in the first month of insurance).

# If you have a claim, or are involved in an incident that could lead to a claim:

you must advise us immediately, preferably in writing. Your policy will contain conditions that relate to the early reporting of potential claims and it is important that you do not breach this responsibility.

# Your obligations:

- ☐ Ensure that you provide true and complete information. For example: State your correct previous insurance history or provide the correct details of the regular driver of your vehicle.
- ☐ Inform us immediately of any risk change on your policy. For example: Tell us when your sums insured increase, when your risk address changes or when you replace your vehicle.

Complaints must be in writing and submitted with supporting documentation to the Compliance Officer.

If you are not satisfied with the way your complaint is handled, you have the right to ask the FAIS ombudsman to review your case.
